In consideration of the payments to be made by the purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the PE to provide the goods (Ventilator Machine for NICU & Cathlab) and related services and to remedy any defects there in conformity in all respects with the provisions of the Contract.
4. The PE, hereby covenants to pay the Supplier in consideration of the provision of the goods (Ventilator Machine for NICU & Cathlab) and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
